CONVENTION PROPOSALS

In order to compare proposals from convention locations on an even scale the convention locations are to be submitted to the New York State Executive Board at least TWO MONTHS before the start of the convention so the proposal can be evaluated and there would be time to obtain any missing items and clarification to any concerns that the executive board may have with the proposal.

The following items are to be address and prices quoted:

3 rooms advance board members with dinner, day before the registration begins (usually complementary)

3 night stay for convention attendees

First night reception one hour (Drinks and snacks) followed by dinner (alternative barbecue)

Second day breakfast, lunch, dinner

Third day breakfast, lunch and dinner

Last day breakfast and box lunch

2 Morning Breaks (second and third day) (coffee, tea and pastries)

2 afternoon breaks (second and third day) (soda, cookies, milk)

Meeting room 2 days (possibly 3rd day morning session)

Room after meeting for fund raiser

Hospitality room 4 days (to include fridge, TV and tables for after meeting)

Is there a charge for food and beverage, we bring into the hospitality room

Audio visual equipment

Location with tables for registration on first night

Any gratuities and taxes to be imposed on everyone

Meeting room to be class room seating

Provide Cold Water during morning and afternoon meeting times.

Will there be any additional charges from the site for services or material used by us.

NAPS New York State Legislative Update

Postal Reform will most likely not be voted on by the Senate Homeland Security and Government Affairs Committee until the next session of Congress in 2014. Roadblocks continue to emerge forcing changes in the language to amend the bill. The latest markup that was scheduled for November 6, 2013 was delayed indefinitely due to lack of support by Democrats.

Committee Chairman Senator Tom Carper, D-DE and Ranking Member Senator Tom Coburn, R-OK introduced some reform to S-1468, which they had hoped would be voted on before Thanksgiving but were still unable to get enough support due to concerns by other members of the committee and stakeholder groups.

Additional amendments were filed by other committee members prior to the December 16, 2013 deadline for a markup scheduled for December 18, 2013.

Senator Tammy Baldwin, D-WI, does not support the bill and has introduced an amendment to eliminate a provision in the Carper/ Coburn bill that would give the Postal Service more freedom in setting prices.

Senator Jon Tester, D-MT and Senator Heidi Heitkamp D-ND have concerns with cutting six day delivery and door-to-door delivery which unfairly targets rural states.

The major hurdles continue to be reduction of six day delivery, healthcare costs and pricing. Once past these issues the remainder must be streamlined in order to quickly move forward.

Needless to say, the December 18, 2013 mark up was postponed.
